1. Introduction

This study contains information on legal frames and/or other regulations for supervision & coaching, business and management consulting and psychotherapy in Europe.

The first step we took was the exploration of relevant data (institutions, organizations, key-person etc.) via internet and telephone using ANSE website as a first orientation platform. We asked for support the Austrian Chamber of Trade and Commerce and its representations in the European countries, and all ANSE members.

A second step was made up of the gained information the explored institutions /persons had sent back. We selected, crosschecked and filled it into a matrix.

In a third step a design was developed. You will find a first cross-country matrix, where you can catch a short and quick overview. To get more on detailed information have a look on the national matrices afterwards. Here all collected information is visible (including the sources). If material is attached you will find a note and the document in the attachment.

A short reflection on the research process and some eye-catching characteristics closes the study.

The ECVISION project promises to develop the very first common basis for supervision and coaching in Europe by means of the contemporary concepts of core tasks and competences. During the many activities in the professional association for supervision and coaching, the needs for the transparency and comparability of different approaches and various training programs for both forms of consulting have emerged. The project aims to offer to the professional society a useful platform for comparison of different approaches to training and to the customers a clear overview of what Supervision and Coaching is offering them.

Expected results of the three year Development of Innovation Project are:

The Glossary of supervision and coaching terminology serves as the basis for the further development of products. The Glossary aims at assuring comparability of terms, definitions and legal frameworks; It will be available in the languages of all consortium partners, partly in French as well. The Glossary offers even more – a clear overview of the concepts, core qualities, types, settings, methods, outcomes and stakeholders of supervision and coaching.

The Competence Matrix will assure comparability of supervisory competences and qualifications in reference to professional tasks. The competences will be described in Learning Outcomes on stages of competence development from 4 to 7, according to the European Qualifications Framework.

The comparison and the correspondence between different types of the training programs will derive from the competence matrix, and go through related Learning Units back to their curricula. By Learning Units, the project partners consider the components of a qualification, consisting of a coherent set of knowledge, skills and competence that can be assessed and validated.

As the project is tackling the question of comparability and correspondence between the university study courses for supervision and training courses at the training institutes, describing Learning Units for both, academic and private VET programs. Furthermore, the project will provide a Correspondence Table between ECVET and ECTS.

5. Summary

One of the main problems was the language of the sources. Only a few homepages of the national organization and institutions were in English as well. Normally they are available only in the mother tongue. A lot of the first contacts remained un replied.

The phenomenon we were confronted with is the bewildering diversity of national descriptions, definitions of methods of supervision and coaching. Proclaimed characteristics of coaching, and more clearly and specifically of supervision, differ from country to country.

It was possible to overcome all these difficulties. It can be said that Supervision and Coaching mainly run without any legal regulation. Only Croatia and Slovenia –2 from 22 nations – got a legal frame.

Business and management consulting is partly regulated. Organizational consulting is not mentioned. Austria and Germany provide regulations and a legal frame for psychotherapy.

Although this background of missing legal frames for supervision and coaching, national organization for supervision and coaching set up their own regulations and standards.
