## History of the Association

- In April 1997, Victor Menovshchikov (who then was Director of Regional center for psychological and pedagogical assistance to the population in Perm) won the competition for free training in the international supervisor training program in Austria. The program was organized by the charity organization KEAR OSTERREICH. My studies started in Vienna in November 1997.
- On November 21, 1997, ANSE, the Association of National Supervisory Organizations in Europe, was founded there in Vienna. Its founding members were national organizations from Germany, Switzerland, Austria, the Netherlands and Hungary. Louis van Kessel was elected President of ANSE.
- Svetlana Borisova, a fellow student of Victor Menovshchikov in the supervisor training program in Austria, participated in the opening ceremony of ANSE as a representative of Russia.

- In November 1999, Victor Menovshchikov completed his training in the international supervisor training program in Austria and received a supervisor's diploma.
- At the same time, Victor Menovshchikov was included in the number of ANSE contact persons in Europe (as a representative of Russia).

## 2000

- In October 2000, Victor Menovshchikov took part in the first ANSE conference "Supervision and coaching" in Munich.
- There he met with the President of the ANSE Louis van Kessel. Some directions for cooperation were discussed.

## 2001

- The annual conference "Psychological counseling and psychotherapy" was held in Perm from February 26 to March 1, 2001.
- The conference was attended by ANSE President Louis van Kessel and head of the Hungarian national Association of supervisors – George Sarvari.

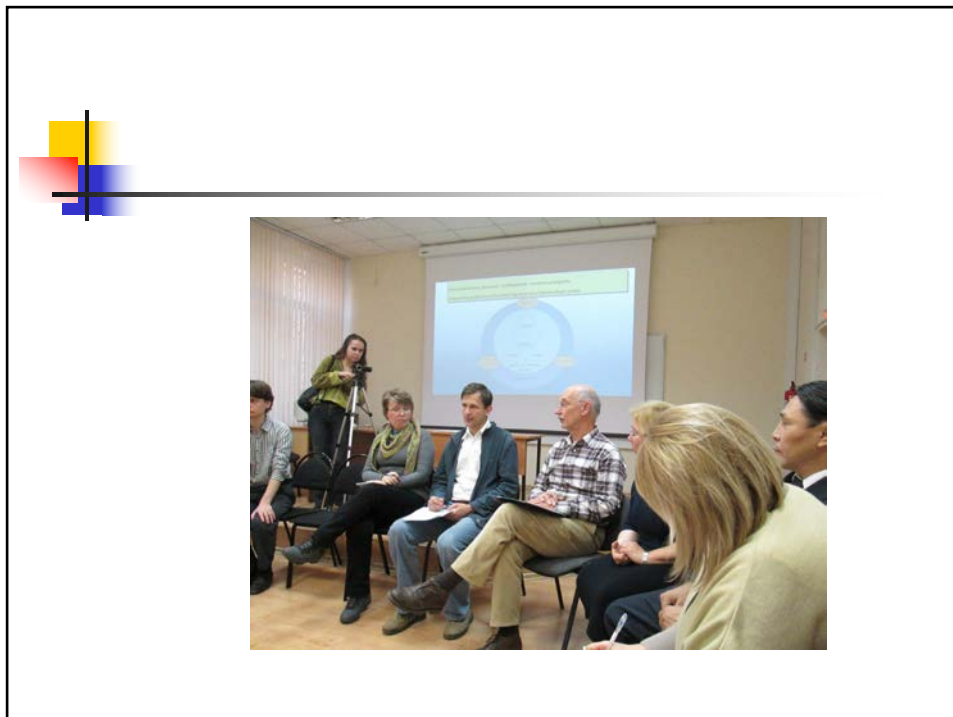

## 2015

- In October 2015, Louis van Kessel was invited by Victor Menovshchikov to participate in a conference at the HSE.
- The idea of creating a Russian Supervisory organization that will be able to join ANSE and conduct an International supervisor training program is discussed.

## 2018

- March 21 – start of The international supervisor training program (Louis van Kessel held the first webinar).
- On April 25, Louis van Kessel takes part in the II All-Russian scientific and practical conference "Counseling psychology and non-clinical psychotherapy" at the RSSU (Main organizers, co-chairs of the organizing Committee- E. A. Petrova, V. Yu. Menovshchikov).
- On April 26 – 28, the first Louis van Kessel workshop was held as part of The international supervisor training program

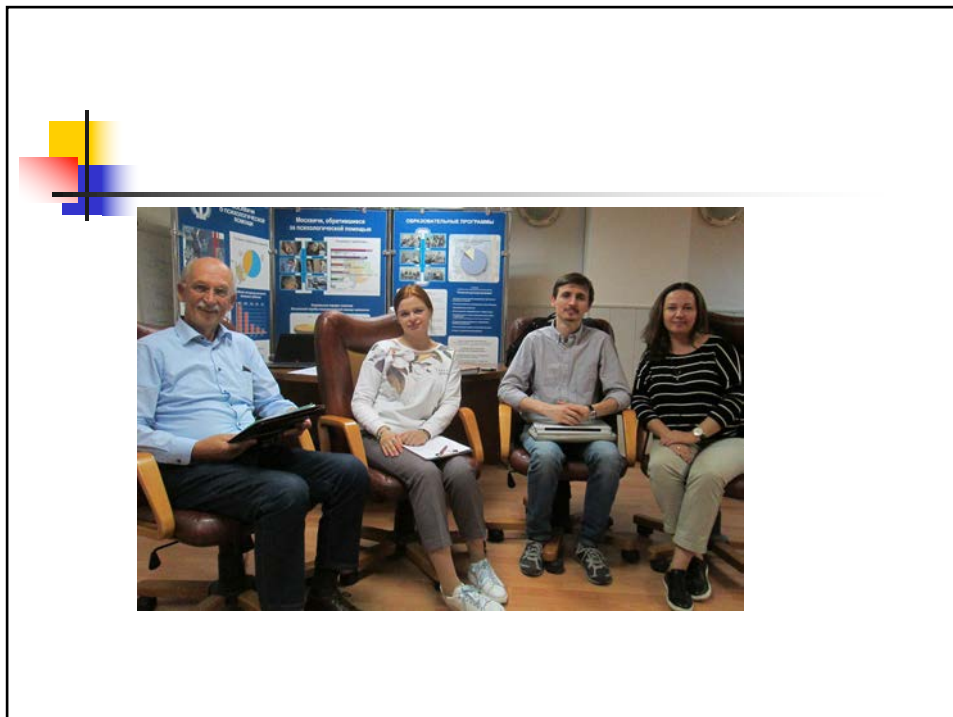

## 2020 год

- In 2019, Victor Menovshchikov organized a working group to create the National Association of supervisors of Russia. The ance BOARD clarified the conditions for the national organization to join the European Association of supervisors.
- Victor Menovshchikov officially registered the national Association of supervisors (Russia). The entry about the non-profit organization was entered in the Unified state register of legal entities on January 29, 2020
- April 21 — members of the Working group Darchieva N., Elakova S., Mikhailov V., Plusheva O., Zhigulina M., Ryazantseva E. joined the Association. They elected the Board of the National Association of supervisors (Russia). Natalia Panfilova-Darchieva was elected Executive Director of the Association.
- The international supervisor training program (Louis van Kessel) was completed in may

## National Association of Supervisors

Goal of the association is:

- Improving the quality of supervision in Russian Federation as a service to all type of practitioners and managers in the educational programs and providers of human service activities;
- Improving and guarding the competences of supervisors and professional coaches;
- Organizing supervisors and professional coaches as a professional community and offering them the possibility to exchange information, to participate in activities of continued professional development.

## *What are the conditions to become a member?*

- Members of the Association may be citizens of the Russian Federation who share the goals of the Association and contribute to their implementation. They pay their annual membership fees and are implementing the provisions of the Statutes of the association.

Full members have passed an examination of a supervisor training program that is accredited by the Association.

- Candidates for participation in a supervisor training program must have at least a diploma of a training program at the bachelor's level in a human service profession, three years of professional practice, and passing their own supervision, which is at least 15 sessions in group or dyad format.

## *What is your definition for supervision?*

- Supervision is seen as a special type of counseling/consultation, which is part of the training and continued professional development of practicing workers and administrators, and as a method of professional development by means of reflection on own functioning in human service practice.

### ***Number of members***

- At this moment 6 full members (and 12 candidates who will complete the training program in May-June 2020).
- One member passed the examination of a supervisor training program in Austria (1999).
- Thus, the members represent at least two different supervisor training institutes.

## *How do you see your activities within ANSE?*

- In the Russian Federation, supervision as an integrated approach for a variety of human service professions is new and its dissemination is starting. Until the start of the international supervisor training program (see above) in Russia those who function as supervisor in practice are only more or less educated in a supervision as is conceived and practiced in a specific psychotherapeutic (school- or method bound) approach.
- The members of our association implement and disseminate the general integrated approach of supervision as advocated by ANSE. Because we are a small group in a big country we need professional contacts with colleagues within the professional community of ANSE. We need the inspiration of other European colleagues and associations to develop our theory and practice of supervision as well as the organizational structure of our association. From our side we can offer the European colleagues knowledge and experiences we collect in our country
