Exchanging and Validating Good Practice of Lifelong Development of Supervisory

Competences of Supervision in EUROPE “SuperPrax”

Budget: 184.624,00 EUR (lumpsums for administrative expenses, traveling for meetings of training activities and translation for products)

Length: 2-year Strategic Partnership project

Main aims and objectives planned:

- Share and collect ideas, good practice examples of offline and online methods to develop and evaluate supervisory competences from different sectors of VET.
- Explore the potential of digital technologies to facilitate competence development and the validation of competences of supervisors.
- Foster quality improvements of the educations of Partners by implementing new methods and innovative practices.
- Strengthen the professional development of educators of supervision through exchange and peer-learning.
- Create knowledge base as a possible further step to develop blended learning curricula.
- Improve the educators' ability handling diversity using more adapted teaching methods.

Activities

The core activity would have been knowledge exchange in Short term joint staff training events. Consortium meetings for exchanging and teaching good practice examples of methods to develop supervisory competencies.

We planned both online and face-to-face meetings among teachers, educators and responsible members from the partner organizations. Every event organized by a different consortium partner and held in a different European country.

Results and products:

The main outcome - a strengthened cross-sectoral co-operation and a created platform for further co-operation in the process of lifelong development of supervisory competences and development of quality of supervision in Europe.

European Survey on supervision educations

We planned to launch a survey on the postgraduate supervision educations in the European countries. The aim - to collect and compare data about the standards, requirements, levels and other specifics of the different educations from as many European countries as possible.

Good Practice Manual and Booklet

The main product would have been the collection of good practice methods for lifelong development and evaluation of supervisory competences.

We planned to put special emphasis on collecting good practice examples of digital online teaching methods developing the supervisory competences.

The Booklet - summarized version translated into 13 European languages.

Potential longer-term benefits

The project planned to provide a collection of new and innovative competence development methods which could be carried out cross-sectoral and transnationally in Europe.

Based upon the results of SuperPrax project there was planned to move towards a common European standard for educations of supervisors. The further goal of Mutual Recognition could be a clarification of competence-oriented development and Quality System of Supervision in Europe and increased mobility of the supervisors.
